What are we voting for?

At the 2016 voters meeting we voted to begin a process of calling a full time worker in the area of youth ministry. Our official title for this position is Director of Education. The job description was very similar to what is attached to this document. The attached document is the official job description that Kristen will have the opportunity to agree to and be evaluated on.

The path that we chose was to hire a DCE (Director of Christian Education) out of one of our Concordia Universities with the hope that the intern placed with us would stay for more than one year. We followed that path and Concordia Austin, Texas placed Kristen Kocsis with us. In May, her internship will be finished and she will be a certified DCE within the Lutheran Church Missouri Synod.

We are voting to extend a call to her. A yes vote says we will **extend her a call to work at Resurrection Ministries**. A no vote says we will not extend her a call to work at Resurrection Ministries.

What do we mean by "call"?

Article 14 of the Augsburg Confession (one of the formal Lutheran confessional writings) says, "It is taught among us that no one should publicly teach or preach or administer the sacraments in the church without a regular call."

A Divine Call comes from God <u>through</u> the calling entity (in this case, Resurrection Ministries) and is extended by God <u>to</u> the Called person (in this case, Kristen Kocsis). Thus, congregations, district officials, synodical officials, and college/university placement directors in the Concordia University System work together cooperatively to provide the calling entity with workers who are qualified and capable of carrying out the mission and ministry that the Lord has entrusted to the local church.

What percentage vote is needed?

Our By-laws call for a 2/3 vote.

Who can vote?

Those who filled out our "voter renewal" form will be eligible to vote. If you did not fill out this form for 2018, please contact the church office.

What happens after the vote?

Assuming the vote passes to extend Kristen the Call, we enter into a time of document processing. The Call documents go to our district and then to Concordia Austin, TX and

then to Kristen and then to the Synod. After all of that we get to officially install Kristen and celebrate her work among us (this would probably happen in late July).

Experiences at Rez.

- We feel that we have been extremely blessed to have Kristen placed with us by Concordia Austin, TX.
- She has consistently gotten on the campus of Liberty High School, attempting to connect with unchurched youth. (She's also had some time on the campus of Heritage).
- She has consistently done ministry WITH the youth (as opposed to doing it FOR the youth).
- She consistently provides weekly Sunday night opportunities for youth to connect with Jesus and each other. (As well as the same type of opportunities in the middle of the week.)
- She consistently provides opportunities for youth to have one on one time with her.
- She has planned and led most of the major events for youth ministry in the last 12 months.
- She has connected with Wee Care parents, children and teachers.
- She has shown initiative and positive follow through.
- She has a teachable and humble spirit.
- She has a heart for the mission of God and is a supportive voice in our congregations discipleship journey.
- She has demonstrated good character, integrity and a love for Jesus.
